ORDER :

In the G.O.first read above, orders were issued that the concessions applicable to the dependents of Andhra Pradesh State Government Employees who die in harness be extended to the dependents of the Defence Personnel also who die in action or become disabled in action, subject to the conditions stipulated in G.O.Ms.No.1005 Employment & Social Welfare Department dated 27-12-1974 read with Govt.Memo No.529/G1/75-8E & SW,dt.19-8-75.

2. As the orders issued in G.O.Ms.No.1005 E & SW Dept., dt. 27-12-1974 were superceeded in the G.O.second read above, the concessions extended in the G.O.first read above to the defence personnel became inoperative.

3. The Government have examined the question of extending the benefits given to the State Government Employees in the G.O.second read above, to the kith and kin of the defence personnel belonging to Andhra Pradesh State who are killed in action/ disabled in action, keeping in view the other concessions granted to them by the Government of India in Circular No.2646/DG12/Empl/RES-B, dated 08-04-1975 of the Ministry of Defence and in Office Memo.No.14/1/66 Estt.(D), DT.03-12-1966 of the Ministry of Home Affairs.

4. After careful examination, the Government have decided that instead of issuing general orders modifying the State Government's existing policy (issue in the G.O.second read above) each case of compassionate appointment of Son/Daughter/Spouse of Defence Personnel (belonging to Andhra Pradesh) who die in action or disabled in action, be examined by Government on merits depending on the circumstances of the case.

5. The Director, Sainik Welfare, Hyderabad shall accordingly send the individual cases to Government for orders.
