**ORDER:**

In the G.O. first read above, orders were issued restoring the scheme of compassionate appointments to the dependents of defence personnel killed/ disabled in action as ordered in G.O.Ms.No.42, Home (Genl.B) Department, dated : 11-02-1993, and in G.O.Ms.No.617, Revenue (L.R.) Department, dated : 27-09-2002.

In the reference fourth read above, the Director Sainik Welfare has stated that the defence personnel guard our motherland in the most unfavorable condition and are killed in action in the War front and leave behind their families in a most distressed condition which needs moral, emotional and financial support from the state Government. The loss that they have incurred is inconsolable and irreparable. As such, the Government have to strive to make good the loss that they have incurred in losing their dear ones for the Nation. The detailed procedure for compassionate appointment for the dependents of the Government Servants are covered in the G.O, Second read above, and therefore, the provisions of the said G.O. are also applicable to the defence personnel killed in action or battle disabled.

3. Government after careful examination of the matter, hereby extend the orders issued in G.O.Ms.No.612, G.A.(Ser.A) Department, dated : 30-10-1991, as subsequently amended to the dependents of defence personnel belonging to Andhra Pradesh who are killed / disabled in action.
