ORDER:

Orders were Issued in the G.O.s in the references 1 to 3 above, that members of the Defence services, who distinguished themselves by acts of Gallantry in the field should be given monetary grants at the rates indicated therein.

2. The Hon'ble Chief Minister has announced on the floor of the Legislative Assembly on 17.01.2017 that the Cash Grants to the Gallantry Award winners of Armed Forces personnel belonging to Telangana State will be enhanced to the following amounts as compared to the previous amounts given in united AP and higher than the cash grants being given in other states:

- 1) Param Vir Chakra & Ashoka Chakra : 2.25 Crores
- 2) Maha Vir Chakra & Kirti Chakra : 1.25 Crores
- 3) Vir Chakra & Shourya Chakra : 75 Lacs.
- 4) Sena Medal (Gallantry) : 30 Lacs
- 5) Mentioned in Despatches(Gallantry) : 25 Lacs.
- 6) Sarvottam Yuddh Seva Medal : 25 Lacs.
- 7) Uttam Yuddh Seva Medal : 20 Lacs
- 8) Yuddh Seva Medal : 5 Lacs

3. The Government after careful examination of the matter and in modification of the orders issued in the G.O.s 1st to 3rd read above here by order, the following awards enhanced for Awardees (based on the notification issued by the Secretariat of Hon'ble President of India on or after 02.06.2014, i.e. on or after the date of formation of Telangana State) as One time lump sum cash grant and the awardees will not be entitled to any other benefits, i.e. Cash in lieu of land and annuity.

4. The monetary grants mentioned above are applicable for Awardees based on the notification issued by the Secretariat of Hon'ble President of India on or after 02.06.2014, i.e. on or after the date of formation of Telangana State.

5. The Armed Forces personnel being awarded the same Gallantry award more than once are notified as 'bar' to the award may be provided the same amount again as and when awarded as per rules at that time. In case an awardee is awarded a different Gallantry award subsequently, the amount applicable for that award will be provided as per rules existing at that time. The monetary grants mentioned above are restricted to personnel belonging to Telangana State by birth or domicile as per permanent address given at the time of joining the armed forces and as recorded in their service records.

6. In case the awardee has declared his temporary address as his permanent address at the time of joining Armed Forces due to employment of his father or his studies but originally a resident of Telangana State, the permanent home address of his father as recorded in his father's service document may be considered for deciding the domicile status for grant of Onetime Lumpsum Cash Award. All cases for sanction of Cash Grants would be submitted through the office of Regional/Zilla Sainik Welfare Office along with an affidavit that the awardee has not claimed similar grant from the State Government or any other state Government for that award.

7. The expenditure sanctioned in para 3 shall be debited to "2070-Other Administrative Services - MH - 800 Other Expenditure - SH (16) Monetary Assistance to the recipients of Gallantry Awards".

8. This order issues with the concurrence of Finance (EBS.I) Department vide their U.O.No.1467/144/EBS.I/A1/18, dt.12.06.2018.
