ORDER:

The following notification will be published in the Andhra Pradesh Gazette:-

NOTIFICATION

In exercise of the powers conferred by the proviso to article 309 read with Clause (i) of Article 16 and Article 335 of the Constitution of India, the Governor of Andhra Pradesh State and Subordinate Services Rules.

The amendments hereby made shall be deemed to have come into force with effect from the 15th July, 1986.

AMENDMENTS

In Rule 22 of Part-II of the said rules -

- I. In sub-rule (ii), -
- (I) for clause (2) and the provisos there under, the following shall be substituted, namely:-
 - " (a) the unit of appointments for the purpose of this rule shall be one hundred of which fifteen shall be reserved for the Scheduled Castes, six shall be reserved for the Scheduled Tribes, twenty-five shall be reserved for the Backward Classes and the remaining fifty-four appointments shall be on the basis of open competition.

Provided that where any special rules lay down that appointments shall also be reserved for physically handicapped persons, out of fifty-four appointments to be made on the basis of open competition, three appointments shall be reserved for direct recruitment for the physically handicapped persons;

Provided further that in the case of appointments to clerical posts including the posts of Typists, i.e. in Group-II and Group-IV and in the case of posts in the A.P.Police Subordinate Service, to which the principle of reservation of appointments applies out of the fifty-four, as the case may be, fifty one appointment to be made on the basis of open competition, two appointments shall be reserved for direct recruitment of ex-servicemen.

Provided also that in the case of appointments to the posts of Senior Assistants, Junior Assistants, Typists, Junior Stenographers and Record Assistants in the offices of Heads of Departments, Assistant Section officers, Typist-cum-Assistants, Junior Stenographers and Record Assistants in the Secretariat to which the principle of reservation of appointments applies, out of fifty-four, as the case may be, forty-nine appointments to be made on the basis of open competition, one appointment shall be reserved for direct recruitment to Meritorious Sportsmen".

- (2) for clause (c) and the provisos (i) and (v) there under, the following shall be substituted, namely:-
 - "C) Appointments under this rule shall be made in the order of rotation specified below in a unit of hundred vacancies:-

Provided that :-

(i) in the case of appointment to posts referred to in the second proviso to sub-rule (a) the 12th and 37th turns in each unit of hundred vacancies shall be reserved for Ex-servicemen. However, that wherever the special or adhoc-rules provide that there shall be no reservation for Ex-servicemen or if a qualified and suitable candidate is not available from Ex-servicemen, the turn allotted to Ex-servicemen shall be deemed to be allotted to Open Competition.

- (ii) Where the special or ad-hoc rules provide for reservation in favour of physically handicapped persons, the 6th, 31st and 56th turns in each unit of hundred vacancies shall be allotted to the physically handicapped persons and where qualified and suitable candidates are not available from among the physically handicapped persons, the turn allotted for them in the unit referred to above shall be carried forward for three succeeding recruitment years and the reservation for those vacancies shall cease thereafter.
- II. In clause (i) of sub-rule (g) and the proviso there under for the expression "50%" wherever they occur, the expression "52%" shall be substituted and for the expression "14%" and "4%" occurring in the said proviso, the expression "15%" and "6%" respectively shall be substituted.
- III. In clause (i) and (ii) of sub-rule (h) for the expression "8th August 1975", the expression "15th July, 1986" shall be substituted.
