Establishment – Sainik Welfare Department – Extension of benefits of compassionate appointment to the deceased or disabled defence personnel belonging to Andhra Pradesh State – Orders – Issued.

ORDER:

The Government have issued orders in GO Ms No.1005 Empt. & SW (G) Dept. dt 27.12.74 relaxing the employment exchange procedure for purpose of making appointment of the spouse of the deceased Government servants of State Government or dependent children who died in harness, as a social security measure. Subsequently, Government evolved a policy in G.O Ms No.687 General Administration (Ser.A) Department. dt 3.10.1977 for providing permanent relief to the family of a deceased Government servant who dies in hare ness by appointing his son / daughter / spouse subject to certain conditions specified there in, and several instructions are issued on the scheme from time to time for its effective implementation. The main object in having the scheme is to see that the family of the deceased Government servant is not thrown out of the streets immediately after his death.

2. In GO Ms.No612 General Administration (Ser-A) Department dt.30.10.91 orders were issued afresh in modification of earlier orders issued from time to time wherever they are in consistent with those orders. The following instructions, among others, issued in the above said GO are that:

1) The younger brother / sister of the deceased Government servant who remained unmarried (the deceased Government employee happens to have remained unmarried) can be considered for appointment under the scheme provided there is no other earning member in the family.

2) Adopted son or daughter of the deceased Government servant may be considered for appointment if the adoption had taken place legally atleast five years prior to the date of demise of Government servant.

3) In GO Ms No.895 LE&TE Dept. dt. 18.8.1977 Government have issued orders separately extending the concessions. Applicable to the dependents of Andhra Pradesh State Government employees to those of defence personnel also who die in action or become disabled in action subject to the conditions stipulated in GO Ms No.1005 Social Welfare Department. dt 27.12.74 read with Govt. Memo No.529/G1/75-8 E&SW dt 19.8.75.

4) As the orders issued in GO Ms No.1005 E & SW Dept. dated 27.12.74 were superceded by GO Ms.No.687 GA (Ser.A) Dept Dated 3.10.1977 the concessions extended to the defence personnel in GO Ms.No.895 LE& TE Dept dated 18.8.1977 became in operative. Government having examined the same issued orders afresh in GO Ms No.42 Home (Genl.B) Department dated 11.2.1993 that the cases of compassionate appointment pertaining to defence personnel belonging to state of Andhra Pradesh be examined on merit depending on the circumstances of the cases. Accordingly the cases of diseased or disabled defence personnel of state of Andhra Pradesh are being considered on merit depending on the circumstances of each cases.

5) At this stage the Director Sainik Welfare has sent proposals in the reference 3rd read above stating that, most of the parents of deceased defence personnel are requesting to provide employment assistance to the brother / sister / adopted son of deceased soldier as a social security measure on par with the deceased state Government employees provided in GO Ms No.687 General Administration (Ser.A) Dept. dt.3.10.77. He has there fore requested to issue of orders in the matter.

6) Government after careful examination of the above proposal of Director of Sainik Welfare, A.P., Hyderabad have decided to accept the same and accordingly the following orders are issued.

i) The younger brother / Sister of the deceased / disabled defence personnel who remained unmarried (the deceased defence personnel happens to have remained unmarried) can be considered for appointment under the scheme provided that there is no other earning member in the family belonging to the State of Andhra Pradesh.

And

ii) Adopted son or daughter of the deceased / disabled defence personnel can be considered for appointment if the adoption had taken place legally atleast five years prior to the date of demise or desableness of defence personnel belonging to State of Andhra Pradesh.

The Director Sainik Welfare, Hyderabad shall accordingly send the individual cases to Government for orders.
